Adaptive Computer Basics relating to how computer works at a self paced level.


Career Prep

a comprehensive, rigorous program designed to prepare students who are Developmentally Delayed Learners (or students who have intellectual disabilities) for the world of work as well as with vocational and community training and independent living skills necessary to become successful, contributing community members. Practical job preparation and independent living skills are emphasized in a series of courses designed for individualized progress. Courses are staffed by professional, credentialed special education instructors assisted by skilled instructional assistants.

Adapted Physical Education

GAVILAN COLLEGE WAIII PROGRAM

Program Highlights and Features

Purpose

 The purpose of the WAIII program is to serve DOR consumers who are eligible for services in the San Jose District. The Specialized Services are designed as preplan and in plan services that are not offered elsewhere on campus. Our mission is to work closely with the DOR counselors to provide employment services that lead to successful case outcomes based on individual cases and what is outlined in their DOR Individualized Plan for Employment (IPE).



Eligibility

- Any person with a disability could be eligible for DOR and WAIII services.
- They must want to go to work at some point now or in the future.
- They must be eligible to work in the United States.
- If they have a physical disability, they must have a doctor's clearance prior to participating.
- They should have documentation related to their disability such as doctor's report, educational assessment, Social Security Eligibility docs etc.
- Their disability has to be considered permanent or long term to be considered for eligibility.

Referral Process

- The current referral process is a two way system in which DRC staff identify potential candidates though regular interfacing as well as direct referrals form the DOR counselors from the district.
- If a possible referral is identified through DRC staff, the student is set up with an appointment to meet with WAIII staff for screening and additional information about the DOR/WAIII program. If still interested, the student is set up with an appointment for an intake with DOR staff.

Possible Benefits for our Students

- Tuition, books and supplies may be paid if student has an employment goal in which training is warranted.
- Case management added layer of support for students struggling with transition, advocacy, personal/social issues and other significant barriers.
- Employment Services Assessment, Guidance 530, Preemployment Development, Employment search, Career exploration, Employment Retention Services, Job Coaching (coming soon) etc.
- Support services and connection even after graduation.

Service Categories

- Vocational Assessment/ Career Exploration Services
 - These have been designed to assist the Consumer and referring DOR counselor in deciding eligibility ,identifying strengths, resources, abilities and interests and determining services. The Program Supervisor will staff the referral with the DOR counselor to determine appropriate action in the case.
- Upon completion of these services, a thorough report will be issued to the DOR counselor with a summary of findings and recommendations for the case. This report Template has been approved by DOR contract staff.

Service Categories

- <u>Employment Services</u> All services are in direct correlation to the consumers IPE related goals. These services are tailored to the specific needs of the individual through intakes and staffing's. The services include vocational guidance and instruction to individuals regarding job search skills/activities and appropriate work related behaviors designed to improve the consumer's overall employability.
- These services be done through a one-on-one setting or in classroom training.



Service Categories

 Job Development and Placement – The WAIII Job Developer will contact employers and create networks to develop individualized job leads and bring community awareness to the benefits of working with our consumers. We also create working resume's, cover letters, master applications and other essential pre-employment documents needed to have a consumers ready for future opportunities.



Retention Services

 <u>Employment Retention Services</u> – Continued communication with consumer and potential employers following placement. We will intervene if needed to allow consumer to acclimate to new employment experience.
Employment information is shared immediately with DOR counselor through Job Cards which include information needed for the AWARE System.



Activities on the Horizon

- Stronger Communication between Gavilan College, Community Partners and Local Employers.
- Hosting multiple on campus events designed to bring light to areas of need within the disability employment field.
- Providing outreach and creating exposure for our program to allow for partnerships and possible referral sources.
- Collaboration with outside agencies for events designed to educate local area on disability awareness.
