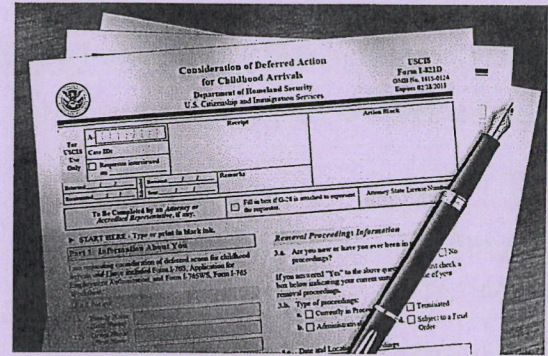

When you receive a consultation from SIREN:

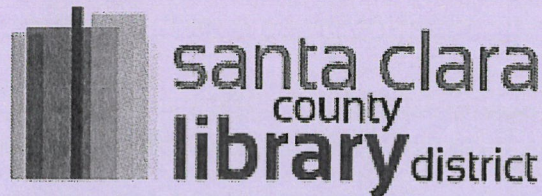
1. We explain your rights, as well as the requirements and process for applying.


